**REQUESTING THE GREAT LAKES WATER AUTHORITY BE
INVOLVED IN THE DISCUSSIONS TO CHANGE CURRENT LEAD
TESTING RULES**

May 13, 2016

WHEREAS, the Conference of Western Wayne (CWW), a consortium of eighteen Western Wayne communities in Wayne County who serve a total population of 700,000 residents, has joined in an effort to improve local government and enhance the quality of life for area residents through municipal cooperation; and

WHEREAS, the CWW Board of Directors consists of the Chief Elected Officials from all eighteen member communities whose total population exceeds 700,000 and is a region that hosts many essential businesses in the state of Michigan; and

WHEREAS, the Governor of the State of Michigan is pushing for the toughest lead testing rules in the United States based on the recent lead contamination in the City of Flint; and

WHEREAS, the Great Lakes Water Authority (GLWA) is the provider of wholesale water and sewer services for roughly 40 percent of the State of Michigan's population; and

WHEREAS, GLWA has a vested interest as the largest wholesale water and sewer provider in Michigan and as one of the largest providers in the United States in being part of the conversation pertaining to changes in lead testing rules; and

THEREFORE BE IT RESOLVED, the Conference of Western Wayne respectfully requests the Great Lakes Water Authority be directly involved in discussions with the State of Michigan pertaining to changes in lead testing rules;

THEREFORE BE IT FINALLY RESOLVED, that a copy of this resolution be sent to CWW area legislators, the Governor of the State of Michigan, the Lieutenant Governor of the State of Michigan, the Director of the Department of Environmental Quality, the Chair of the Senate Appropriations Committee on Environmental Quality, the Chair of the House Appropriations Committee on Environmental Quality, and the Board of Directors for the Great Lakes Water Authority.
