CWW RESOLUTION 2015-103 **OPPOSING HB 4138/PRESUMPTIVE PAROLE**

June 12, 2015

WHEREAS, The Conference of Western Wayne (CWW), a consortium of eighteen Western Wayne communities in Wayne County who serve a total population of 700,000 residents, has joined in an effort to improve local government and enhance the quality of life for area residents through municipal cooperation; and

WHEREAS, Michigan spends nearly \$2 billion a year on corrections cost and an estimated \$35,000 a year per prisoner; and

WHEREAS, the closing of two Michigan prisons (taking 1300 beds completely off of the books) would yield the corrections system a savings of roughly \$30 million per year; and

WHEREAS, in a statistic that is one of the highest rates in the nation, over 70% of Michigan's prisoners are serving time for violent crimes; and

WHEREAS, over half of all prisoners are serving time for homicide, sexual assault or armed robbery offenses; and

WHEREAS, over two-thirds of all prisoners are serving time for homicide, sexual assault, armed robberies, home invasions or firearm offenses; and

WHEREAS, according to the Prosecuting Attorney's Association of Michigan, 90% of felons are not even sent to prison. They are sentenced to probation, jail and/or diversion programs; and

WHEREAS, only 10% of convicted felons are actually sentenced to prison time, and over 70% of *those* felons are serving time for violent offenses; and

WHEREAS, HB 4138 would allow for prisoners who score a high probability of release score would be presumed, without substantial and compelling reasons otherwise, to not be a menace to society and would be released upon serving their minimum sentence; and

WHEREAS, according to Michigan Attorney General Bill Schuette, the Michigan Parole Board currently releases nearly 70% of “high probability” prisoners at their first minimum release date; and

THEREFORE BE IT RESOLVED, while we commend the Michigan Legislature for exploring cost savings ideas, the incalculable cost of releasing more violent offenders back into our communities warrants a deeper exploration into the annual per prisoner cost in the Michigan corrections system; and

NOW, THEREFORE BE IT FURTHER RESOLVED, that the Conference of Western Wayne offers this resolution in opposition of House Bill 4138.
